The deadline to file such complaints for any creditor added to this case after the date of the initial Notice and Order of Commencement shall be the later of the original deadline or 60 days after the date on the certificate of service of the notice given pursuant to L.B.R. 1009-1.

#### Deadline to Object to Exemptions:

Thirty (30) days after the conclusion of the meeting of creditors.
